- How officers at Pitt are taught to investigate sexual misconduct, from PA training (state police, **D. Stafford and Associates**) and Pitt training, Title IX training, major focus on sexual assault training and how to handle appropriate training
- ii. Students do not receive same type of training, mostly bystander and scenario training
  - 1. Past two years have been affected by pandemic and no in-person training
  - 2. Pitt was on an upwards trend, after 2015-2016 when Title IX became a much bigger topic, Pitt included city police in their efforts to better sexual assault investigative training and prevention
- iii. Rave Guardian: can be used for confidential reporting or tips
- b. Associate Vice Chancellor Pope
  - i. Sexual assault task force: meetings monthly to communicate well with students (both undergrad and grad), looking for ways to do more outreach or make sure resources are available and students feel comfortable.
- c. Dean Panzella
  - i. Training is a priority
    - 1. Communicating with staff and students
    - 2. Making sure students are aware of what is available to them and what is expected of them
  - ii. Investigations of cases if needed
  - iii. Biggest role is in support areas Counseling Center, Health services, Residence life and our Care team or Care managers
    - 1. Considering piloting sexual assault support program for survivors and students who reported cases of sexual assault.
    - 2. As Dean of Students will work with student government, and students at-large to see, hear, and raise their voices and concerns as they arise
  - iv. Hopefully everything is leading to eradication of sexual of assault
  - v. Questions:
    - 1. Students can do in-person or tele-health options for support
    - 2. What is the jurisdiction? Police- 500 yards from any building that Pitt owns or leases. Title IX jurisdiction ANYONE affiliated with campus. If students need an officer even in a city case, the university will grant one for support.
    - 3. Students can do a legal, university, or both investigative process
    - 4. Grad students- have modules to help bring awareness and training for sexual assault awareness
    - 5. Are there preventative measures in place?

- a. Feb 2020- Program for Prevention and Education. Carrie Benson runs the program for the safe peer educators creating conversations about awareness, consents, and similar topics. Shows positive impacts for participants.
- b. Past orientation Dr. Jay Darr from University Counseling Center – Sexual Citizens Program (Stanford) – having conversations about sex (especially for students who had no sex ed. in school) Try to get people to talk about their concerns in a proactive way, instead of coming after
