  - Braydan Issermoyer

### 4. Pittsburgh Regional Transit Listening Meeting

- Irene Frieze Brought up concerns about delivery trucks on Forbes and issues with traffic adjustments.
  - Kevin Sheehy The city is looking at the semantics of how it will work. They are trying to carve out parking spaces for deliveries. Planning is very early in stages.
- David Salcido Will bus amenities still be available for Pitt students, faculty and staff?
  - 1. Kevin Sheehy We are still within our 3-year contract with Pittsburgh Rapid Transit. There have been no discussions about ending this partnership. Pitt was one of the first universities to implement a rider program and Kevin has given presentations to other large MSA about it.

#### 5. Safety Update

- Ted Fritz, VC for Public Safety and Emergency Management
  - i. 30 AEDs were received today. Kevin Caruso is the contact for that project. The bulk are going into residence halls and then academic buildings and the AED map will be updated. John Cooper from communications is working on another tool for locating AEDs /Stop the Bleed and Emergency phones on campus. That map is forthcoming. Currently determining a plan for how often the AEDs are tested and replaced.

ii. Protests continue on campus. They have been peaceful to date. Due to it being an election year, we anticipate more soon.

## 6. Parking Update

- Kevin Sheehy, Assistant VC for Auxiliary Operations and Finance
  - i. Parking Update During the pandemic, parking allowed permits to be put on hold. There are still 400 permits on hold which has slowed down new permits administration. Now able to address the permits that were allowed to be placed on hold during the pandemic as many people are back in the office and or taking advantage of the shared/set day permit offering with the goal of being able to issue new permits to those on the waitlist. Although many permit holders have settled into the new work environment including their parking arrangements, we have a large amount of people that continue to keep their permit on hold as they are not coming to campus daily. We are looking at implementing this at the end of the semester (May 1, 2024). This would allow ample time for people to make decisions on what they want to do with their permit and allow those members that are on leaves of absences or who are remote during the summer months to comply.
  - ii. Introduction of App Pitt Zen for parking. The app will require single sign on and be behind a Pitt firewall. Pitt Mobile will still be available for everyone else.
