Questions related to research from Faculty Assembly Michael Spring

At the next meeting of Faculty Assembly, Vice Provost Mark Redfern and some of the Senate appointees to research related committees will speak to Faculty Assembly. The discussion will be about the current state and future of research at Pitt. This is particularly important as Pitt continues its efforts to increase its recognition as a research leader. Questions and thoughts about open and executive session meetings Michael Spring

From time to time, the meetings of Faculty Assembly, Senate Council, and the Standing Committees of the Senate are held in Executive Session instead of their normal mode, which is open to the University Community. Section 4 of Article IV states:

Standing and Special Committees of the Senate shall meet regularly and report to the Faculty Assembly and Senate Council on matters in areas of their responsibility. They shall provide the Senate Office with the minutes (including the attendance lists) of their meetings, as well as with the dates and brief agendas of their forthcoming meetings. When a Committee meets in Executive Session, a statement of any decision reached and its supporting reasons must be provided to the Senate Office. Five members shall constitute a quorum. Section 7 states:

All meetings are normally open to members of the University community, although Standing Committees may meet in Executive Session when necessary and appropriate for dealing with confidential matters. The question for assembly is this. What are the implications of holding meetings in executive session?

- What gets reported and in what form?
- Who is allowed to stay and who must leave?
- What are members of the committee allowed to talk about?
